

Terms and Conditions

1. Raffle permit

- 1.1. The permit to hold this lottery is held by The SCOOP Foundation & the artist Gerard Byrne's Studio via the Irish fundraising platform www.idonate.ie and is being promoted and conducted for the benefit of SCOOP Foundation of 61 Brighton Road, Dublin 6 (Charity Number: 20072636), as granted by Superintendent Brendan Kelly of Terenure Garda Station on the 1st of August 2021.

2. Terms & Conditions agreement

- 2.1. By entering this Raffle all entrants agree to be bound by these terms and conditions and any other conditions in the messaging or promotions of this. Any entries not complying with these terms and conditions will not be valid. The terms and conditions herein are governed by Irish Law and the parties submit to the exclusive jurisdiction of the Irish Courts.

3. Raffle prize

- 3.1. The prize of this Raffle consists of an original artwork kindly donated to SCOOP foundation by Gerald Byrne titled "The artist on the roof". The painting is oil on canvas measuring 120cm x 60cm in size. The artwork is framed.

4. Purchasing Raffle tickets

- 4.1. The raffle ticket sales will be open until 5pm on 28th of October at (Closing Date).
- 4.2. All raffle entries must be received by the Promoter no later than 5pm on the Closing Date.
- 4.3. To enter the raffle:
 - 4.3.1. Purchase an online raffle ticket at the price of €10 per ticket from the promoter at <https://www.idonate.ie/raffle/gerardbyrnescoopraffle>
- 4.4. Online raffle tickets purchases will be processed via the iDonate platform.
- 4.5. Upon completion a receipt will be issued via nominated email address showing the total amount entered.
- 4.6. On purchase of an online ticket for the raffle draw, all purchasers of tickets are automatically entered.

5. Data Protection

- 5.1. By entering the SCOOP Foundations Art Raffle October 2021, you will be submitting personal data to us. Personal data that you submit to SCOOP Foundation to enter this Raffle, via the iDonate webpage, will be used only in conjunction with your purchasing your ticket and entry into the art raffle in October 2021.
- 5.2. Your information will be used to enter into the raffle draw only. We require at a minimum the following data to ensure we identify the correct winner at the time of the draw:
 - 5.2.1. Name
 - 5.2.2. Email address
 - 5.2.3. Contact number
- 5.3. To enable us to process raffle tickets / donations, we will collect basic payment information as well as your name, home address and email address. These data fields are required for the processing of payments.
- 5.4. **Use of your Data :** By entering the SCOOP Foundation's art raffle you will be required to provide SCOOP with certain personal data. This is necessary to ensure we identify the correct winner at the time of the raffle draw. SCOOP Foundation is the Data Controller, (hereinafter The Promoter) data will be held for a maximum period of 6 months so that in the event of a legal challenge, the support data is available. Data will not be shared with any other Data Controller and will not be processed for any other purpose or event. Comprehensive data security measures are in place to protect personal data.
- 5.5. Data collected for this Raffle will be used exclusively for this Raffle and no other Raffle or purpose or intent of any kind.
- 5.6. To enable us to process raffle tickets / donations, we will collect basic payment information as well as your name, home address and email address. Your name and the amount you've donated will not be displayed on any public page.
- 5.7. Your personal data will only be used for the purposes outlined above and for no other reason.
- 5.8. You can request that your information be withdrawn at any time by submitting a request in writing to katie@scoopfoundation.org. Please note that this may result in forfeiture of your entry into this raffle.
- 5.9. Participants understand that, by entering this Raffle, their information will be used for the purpose of the SCOOP Foundations Raffle October 2021 only, as outlined above.

- 5.10. Participants may, at any time, request that their information may exercise their right to withdraw from this Raffleby writing to katie@scoopfoundation.org. Participants understand that in doing so, they will forfeit their entry into this raffle.
- 5.11. **Your data protection rights** - Data protection concerns the safeguarding of privacy rights of individuals in relation to the processing of their personal data. “Personal data” includes any information relating to a living individual which allows the identification of that individual, which may for example include a name, email address and mobile phone number. In particular, DCU is subject to the provisions of the General Data Protection Regulation (GDPR) and the Data Protection Acts 1988-2018 when it collects and uses your personal data.
- 5.12. Your data protection rights include:
- 5.12.1. The right to access and receive a copy of your personal data
 - 5.12.2. The right to rectification if there is an error or omission in respect of your personal data
 - 5.12.3. The right to erasure of your personal data in certain circumstances
 - 5.12.4. The right to restrict processing of your personal data in certain circumstances
 - 5.12.5. The right to data portability
 - 5.12.6. The right to object to the processing of your personal data in certain circumstances

 - 5.12.8. The Data Protection Commission (DPC) is the national independent authority responsible for upholding data protection rights of individuals under the GDPR. If you are not satisfied with SCOOP’s processing of your personal data, and you wish to lodge a complaint to the DPC, please visit dataprotection.ie
6. **Eligibility:**
- 6.1. The draw is open to all persons aged 18 or over as at the date of the draw.
 - 6.2. There is no limit to the number of raffle tickets a person can purchase.
 - 6.3. The promoter reserves the right to reject any entry (and award the prize to an alternative winner) if it has grounds to believe the entrant

has breached any of these terms and conditions, acted fraudulently or illegally, or on other reasonable grounds and shall have no liability to an entrant for any loss or damage arising from such rejection

- 6.4. The Promoter respects, and is committed to protecting your privacy. The personal information you provide will remain private and will only be used for the sole purpose of this raffle.
- 6.5. By entering the raffle with your contact details on the payment platform you are consenting to the processing of your personal data by SCOOP Foundation for the purpose of the Artwork raffle only.
- 6.6. The promoter reserves the right to cancel, amend, terminate or temporarily suspend this raffle at any time with no liability to any entrant or any third party. If due to unavailability of a particular prize, beyond the promoter's control, the promoter and sponsor reserves the right to substitute a particular prize for another prize of similar value.

7. **Winner Selection:**

- 7.1. The drawing of the prize will be held online on Thursday 28th October 2021 and will be streamed live across SCOOP Foundation social media platforms
- 7.2. The first person to be selected in the raffle gets the artwork.
- 7.3. If *collecting* the prize the winner will be required to provide proof of identity when collecting their prize. Acceptable forms of identification include:
 - 7.3.1. A valid passport
 - 7.3.2. A current Irish driving licence
 - 7.3.3. A National Age Card (issued by An Garda Síochána)
 - 7.3.4. An identification form with a photograph signed by a member of An Garda Síochána
- 7.4. The prizes are non-transferable and only consist of what is listed above.
- 7.5. Winners will be chosen by random name generator: the first ticket drawn wins the prize.
- 7.6. The winner will be notified within 5 working days of the closing date either by email or telephone.
- 7.7. The winner will be announced on SCOOP Foundation's Social media platforms and in the SCOOP Foundation email newsletter.

- 7.8. In the event that we cannot contact any of the winners within 28 calendar days after the draw, another name will be drawn and a new prize-winner will be declared.
 - 7.9. The winner's name will be announced on the SCOOP website, www.scoopfoundation.org.
 - 7.10. By entering the raffle the entrant may be invited to take part in any publicity relating to the raffle draw. The winners names will be announced and available on the results section of the terms once the draw has taken place. Each entrant has the right to refuse to take part in publicity.
 - 7.11. The promoter's decision is final and no further correspondence will be entered into.
 - 7.12. The Promoter accepts no responsibility or liability to the winner for any dissatisfaction with the prize.
 - 7.13. No alternative prize will be offered. The prize is not redeemable for cash. The winners will be required to provide proof of identity when collecting their prize.
- 8. Limitation of Liability:**
- 8.1. If for any reason any aspect of the Raffle Draw does not function correctly, whether by means of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond the control of the promoter that corrupts or affects the administration, integrity or fairness of the Raffle draw then the promoter may at its sole discretion cancel, modify or suspend the promotion and/or invalidate affected entries.

- 9.1. In addition to the Art Raffle SCOOP will be selling a limited number of prints of the original artwork. These prints will be 600 x 500mm in size, giclee / archival pigment.
 - 9.2. Prints are priced at €225 - for online sales and €200 for live event sales.
 - 9.3. SCOOP Crew members can purchase the prints for €175 online with a code and at the live event.
